Visiting a Friend or Loved One

Century Regional Detention Facility (CRDF) would like to assist you in maintaining connections with your loved ones during their incarceration.

Requirements Before a Visit Obtain a Visitor ID Number by selecting one of the following:

- Register online at <https://visit.lasd.org>
- In-person at CRDF Visiting
- Self-service kiosk in the Century Station Main Lobby

Make an Appointment by selecting one of the following:

- Call CRDF Visiting at 323-568-4520 Monday thru Friday, 9:30 am to 4:00 pm (Closed for lunch 1:00 pm to 2:00 pm)
- Self-service kiosk in the Century Station Main Lobby

Allowed Property inside Facility:

- Valid identification
- A single key to your vehicle or to the lockers provided.
- CRDF is a secured site; therefore, you will be subject to a record check.

Types of Identification Accepted:

- Any State Driver's License
- Department of Motor Vehicle Identification card (from any state) with photo
- Military identification with photo
- United States passport or International passport with photo
- Consulate Card issued only by Mexico or Argentina
- Children 14 to 17-years-old must present a current school photo identification card.

On the Day of Arrival:

Arrive 30 minutes prior to your scheduled visit. If adding a visitor or making changes to your appointment, arrive 60 minutes before your scheduled visit. Two visitors are allowed per visit (a child counts as one person). No exceptions. Cellular phones are not allowed. Lockers are available to hold your personal property for 25 cents. Your scheduled visit is not guaranteed and can be cancelled at any time due to unforeseen circumstances.

Reasons Why We May Deny Your Visit

If you have an active warrant for your arrest, you will not be able to visit. All warrants need to be cleared prior to your scheduled appointment.

If you have been incarcerated in a state prison at any time, you must fill out the form

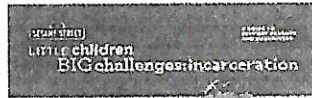
Probationers and Ex-Felons Questionnaire to be considered for a visit.

This form can be found at the CRDF Visiting Center desk or online at www.crdf.lasd.org.

After allowing two weeks for processing, call the CRDF

Visiting Center for your approval status. In addition, all driver licenses, identification cards, and other forms of identification must be approved and valid. Expired, revoked, or suspended identifications are not acceptable.

This free booklet is

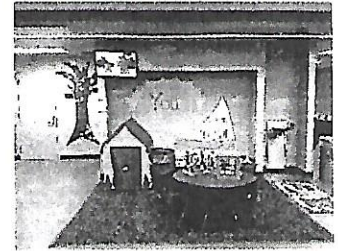
available for families with young children, ages 3 thru 8, who have an incarcerated parent.

Play Area at the CRDF Visiting Center

The CRDF Visiting staff has donated and organized a special place where children can play while they wait for their visit.

This child-friendly area has a colorful mural, which was designed and painted by female inmates. The play area consists of books, toys, and an activity table for children to enjoy.

Direct parental supervision is required at all times.

How Do I...

Pick up an inmate's property?

If you would like to pick up property from an inmate, the inmate must first fill out the *Order for Release of Prisoner's Property* slip. Property will only be released to the named person listed on the property slip.

Completed *Release of Property* slips will be ready for pick-up in one business day at the CRDF Visiting Center desk. You must present valid identification to receive

the property slip. The property slip can be taken to the CRDF Property window or designated station jail.

Drop off an inmate's prescription glasses or contacts?

If you need to drop off prescription glasses or contacts (lens must be clear in color), you must present them to CRDF Visiting staff. The prescription glasses will be inspected and must be in good condition. The glasses must have a

plastic frame. You will need to fill out a *Receipt for Miscellaneous Items* form. The glasses will then be delivered to the inmate within two days.

Pick up an inmate's books?

If a family member would like to pick up an inmate's excess books, the form *Application to Release Books* must be completed. It can be found at the CRDF Visiting Center desk. All inquiries about this service can be answered at the desk.
