- () Do not go anywhere within the shaded area of the attached maps, engage or attempt to engage motorists in conversation, solicit or accept rides from motorists, be stopped or parked in a motor vehicle with any motorist, or loiter, congregate or remain on any public street, sidewalk or alleyway unless engaged in lawful activity.
- () Defendant is to obey all laws, rules and orders of the court and community.
- () Defendant is ordered to appear in Court for PDP Progress report on _____ at 8:30 a.m., in Department _____.
- () Continued for dismissal or sentencing to _____ at 8:30 a.m., in Department _____.
- () If the Defendant successfully completes the PDP, the previously entered plea will be ordered withdrawn and vacated. A new and different plea of Not Guilty will be entered. Upon motion of the Prosecution, the case will be dismissed pursuant to Penal Code Section 1385 and ordered off calendar.

FOR DEFENDANTS WHO QUALIFY FOR 1001.94 P.C. DIVERSION:

- () If the Defendant successfully completes all terms and conditions of the PDP, the Prosecution will consent to the sealing of the arrest report and record of arrest under Penal Code Section 851.8(d). No finding of factual innocence will be made or implied.
- () Failure to comply with terms and conditions of PDP shall result in Entry of Judgment and Sentencing as if Deferral had not occurred.
